## Ken White UBS

Ken joined CDBL 37 years ago, in 1986.

At that time Ken had no children. Today he has a son and a daughter, four grandchildren and another one is on the way.

Ken compared prices of homes, gas and groceries in 1986 to what they are today.

In '86 the #1 song was Walk Like an Egyptian and the first laptop computer came out. The top TV show was the Cosby Show and the #1 movie was Top Gun. It was the year of the space shuttle Challenger explosion and the Chernobyl disaster. Ronald Reagan was president.

The Dow Jones average went from 1793 in '86 to 34,000 today.

Fixed 30 year mortgages were 10.4%, and didn't go below 10% until 1991.

Long term investment is key. Hang in there.

Cut your losses and let runners run.

Investment is a marathon, not a sprint.

Look at where things will be 6 months from now.

When stocks go down, consider them "on sale" - it's a good time to buy.

Be thinking about what the next big thing might be. During COVID, it was medical supplies and anything related to working from home.

Now - Al, supply chain issues, robotics, lack of workers, medical imaging

Ken's "top 10" (or more) reasons to belong to CDBL include breakfast, networking, friendship, expertise, contacts, consistency. #1 for Ken is the stories that members have shared about their businesses, passions and family.

Ken grew up in a blue-collar Pittsburgh neighborhood. He noted that Joe Namath and Joe Montana grew up in similar areas.

Over the last 40 years Ken estimates he has driven to his Albany office 19,200 times.

He has come to around 1400 CDBL meetings at various locations over the years, and has probably been a speaker 75 times.

Ken takes a lot of memories with him as he retires and leaves CDBL.

He was presented with a donation from CDBL to the Scottish Rite, a charity arm of the Masons, in his honor.
