Alan Baker of Creative Marketing Concepts introduced Mark, one of his suppliers for display items.

Mark's company's main business is display products and large scale printing. Tradeshow displays comprise around 45% of Mark's business, such as floor and tabletop displays and banners. Mark does the most business in the 4th quarter of the year, but until recently the company had no offerings for the holidays.

Showdown Designs started creating blankets and pillows that they could print using their existing machinery.

These along with wall products filled the category of holiday decor and gifting.

Branded pillows are available at various sizes and price points.

The turnaround time for these items is two days if vector art with outlined fonts is supplied. 200 dpi photographs will also work for printing.

The pillows are of exceptional quality with YKK zippers and inner pillow provided. Embroidered products are not available.

Various types and sizes of wall display products are also available, with several framing and finish options.

Showdown Displays is located in Minneapolis.

They use domestic sources for the blanket and pillow materials.

A quantity of only one is available on any item and 100% satisfaction is guaranteed.

Most products come with a 1 to 2 year warranty.
