Ann provided 2023 vacancy reports for office and industrial space.

Ann said the office market is doing ok.

The warehouse market is tight.

New medical offices are being built.

There is a new listing at 500 Federal St.Troy. They're looking for new tenants. The SSA office on the first floor is relocating and the space will be renovated.

There is a small retail strip center in S. Glens Falls available, as well as another small center on Pawling Ave. in Troy.

The office market is in trouble. Commercial loans are based on an occupancy ratio.

Many leases are due to expire.

The retail market, however, is still strong.

The Shake Shack is looking for space in the area.

Troy has a parking problem.

Both Macy's locations in this area are staying open.

One or two new Trader Joe's will be opening.

The Grocery Outlet was planning to move to the area, now looks iffy.

Insane Deals, a retail outlet in Mayfield, is looking for more space in Johnstown.

Five major occupants of warehouse space are leaving including Quad Graphics and Mohawk Paper.

Saratoga Water is now marketing nationally and has gone to 2 shifts. They are looking for 75,000 sf of tall warehouse space.

Krispy Kreme is looking for space for a commissary. Most of the ShopRite stores are going to be Price Choppers.
