TODAY'S SPEAKER

Terry Hamlin Oncore Payments

Terry's former business, Transaction Resources, still exists and is part of OnCore.

They are currently adding more tech pieces to the company; more point-of-sale and ecommerce. They provide more options for their clients.

In the two years Terry and his partners have had the new company, they have doubled the company's value, with growth across the board.

The company is headquartered in Williston, VT. The original owners developed software solutions for ski resorts. Transaction Resources brought in their agents and a diverse portfolio of clients and industries.

First Data bought Terry's former company, which became Card Connect. The customer service deteriorated under First Data, and Terry began migrating clients to their new company. Some businesses are going cashless.

Businesses can either add surcharges for credit card payments or offer discounts for those paying cash. They are avoiding absorbing the fees charged by processors and are passing the fees to consumers by building the fees into the cost of service.

Businesses can't do surcharges or cash discounts when customers use debit cards, because they are processed differently.

Merchants are able to set tipping options with credit card payments.

Chip read cards are more secure than swiping.

Cards that you can tap to pay can be risky because some people have near field readers that can pick up your credit card information when they are near you.

Certain wallets can protect your card from being read by devices and AAA also has protective sleeves available.

Apple Pay is not chip read and thus not protected.

When Terry was a banker he had a customer whose debit card stopped working after a few times. This would happen every time they issued her a new debit card. Terry figured out that her eel skin wallet had electrical properties that rendered the debit cards not usable.

Terry said you shouldn't use a debit card to buy anything - use a credit card instead. Banks can reimburse you for phony credit card charges.
